

# Chairman's message

We have trust in the one who lived out, and taught us to pray: "Your will be done on earth as it is in heaven!" We have the certain hope of eternal life because Jesus died and rose to conquer death and Satan. These "haves" are so much more significant than a monetary gain, and we definitely thank God for them.

So, whilst I may not pray for a positive result, I still hope we will have another good year, and that our superannuation scheme will see another year of growth.

We are keen to share the good news about the Scheme among our pastoral leaders. Many of those who are eligible have never joined. Take the opportunity to mention the Scheme to your pastoral colleagues, noting that it offers some additional benefits not generally available from a KiwiSaver Scheme.


### Member nominated directors
