## Amendment to the Scheme's Trust Deed

Attached to this newsletter is a letter from the Trustee which is advising you of a proposal to amend the Scheme's Trust Deed. The amendment relates to the vesting provisions that apply to member's funds so that every contributing member who resigns or ceases active service before age 50 will not only continue to receive 100% of their No 1 Account balance but also in future 100% of their (No. 2) Account balance.

This change recognises that in today's world paid pastoral ministry is not necessarily a calling for life and that many early departures are likely to have been occasioned by exceptional circumstances and this should not trigger a financial penalty.

It's important to note that this communication is just a precursor to the full recommendation that will come at a later date. This is an opportunity for members to read the proposal, ask any questions or raise any concerns. Following feedback, we'll consider any changes that may need to be made, before sending a formal recommendation. Vesting rules require all members of the Scheme to both vote and approve any proposed change.
